### **Rehabilitation of Terjola Water Supply System**

1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Terjola Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/03).
2. *LEPL - Municipal Development Fund of Georgia* (Employer) now invites sealed bids from eligible and qualified bidders for works:

### **Rehabilitation of Terjola Water Supply System**

Main works under the project are:

1. Removal of asphalt layer and disposal to the dump at the 10km distance - 453m<sup>3</sup> ;
2. Excavation of III and IV category soil (manual and machinery) and disposal at the 10km distance - 15,959m<sup>3</sup>;
3. Excavation and leaving the soil on site - 7,731m<sup>3</sup>;
4. Filling the trench with ballast - 8,519m<sup>3</sup>;
5. Arrangement of gravel layer for asphaltting with 0,1m thickness - 17,574m<sup>2</sup>;
6. Sand bedding for pipelines - 4,309m<sup>3</sup>;
7. Arrangement of asphalt layer - 5,200m<sup>2</sup>;
8. Arrangement of polyethylene pipes PN10 PE100 d=125-355mm - 10,508m
9. Arrangement of polyethylene pipes PN10 PE100 d=25-110mm - 28,127m.

Works under this contract are expected to be implemented from July 2014 through April 2015.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.
4. Interested eligible bidders may obtain further information from *Municipal Development Fund of Georgia, Teimuraz Murgulia, Acting Executive Director, [procurement@mdf.org.ge](mailto:procurement@mdf.org.ge)* and inspect the Bidding Documents at the address given below from Monday to Friday 10:00 to 18:00 hours.
5. Qualifications requirements include and are not limited to:
  - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: GEL 2,500,000;
  - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: GEL 500,000.

A margin of preference for certain goods manufactured domestically “*shall not*” be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in ***English language*** may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee *GEL 300* or equivalent in a convertible currency plus courier expenses if a bidder would like the Bidding documents to be sent by Courier. On request, against a faxed copy of the evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Employer bears no responsibility for the delivery in such a case.
