Government of Georgia has allocated funds for **Construction of Gudauri - Kobi Ski Lifts** (*ref: Decree of the Government of Georgia #1371, dated June 30, 2017*).

The *Municipal Development Fund of Georgia* now invites sealed bids from eligible bidders for implementation of Plant Design, Supply and Installation of:

Lot 1: Construction of Gudauri - Kobi Ski Lifts: 9, 10, 11

(GOG/DSI/ICB/01-2017-L1)

Lot 2: Construction of Pirveli and Kudebi Ski Lifts

(GOG/DSI/ICB/01-2017-L2)

The Time for Completion of the whole of the Facilities shall be:

- **Lot 1** Construction of Gudauri Kobi Ski Lifts: 9, 10, 11 15 months (but no later than December 20, 2018)
- Lot 2 Construction of Pirveli and Kudebi Ski Lifts 15 months (but no later than December 20, 2018)

Qualification requirements include:

- 1. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years (2014, 2015, 2016 divided by 3 years) shall be:
 - **Lot 1** GEL 75,600,000.00
 - **Lot 2** GEL 34,800,000.00
- 2. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement:
 - **Lot 1** GEL 12,600,000.00
 - Lot 2 GEL 5,800,000.00
- 3. Participation as contractor, management contractor, or subcontractor, in at least **one** (1) contract in **Georgia** within the last **seven** (7) years that have been successfully and substantially completed and that are similar to the proposed Plant and Installation Services.
- 4. A minimum experience in the following key activities during the last **seven** (7) years:
 - Lot 1: Construction of at least 7 km ski lift under not more than two (2) contacts;
 - Lot 2: Construction of at least 1.5 km ski lift under not more than two (2) contacts.

Note: In order to meet this qualification requirement for both lots the successful bidder shall meet this requirements only for Lot 1.

Bidding will be conducted through the international competitive bidding procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* ("Procurement Guidelines" January 2011, revised July 2014), and is open to all eligible bidders as defined in the guidelines.
