1. The Government of Georgia has received financing from the Asian Development Bank (ADB) towards the cost of Sustainable Urban Transport Investment Program –Tranche 2. Part of this financing will be used for payments under the Contracts named above. Bidding is open to Bidders from eligible source countries of the ADB.

2. The Municipal Development Fund of Georgia (MDF) (hereinafter referred to as the "Employer") invites sealed bids from eligible Bidders for Construction Works of Tbilisi Marshal Gelovani Avenue and Mtkvari Right Bank Intersection. The project includes 2 underpasses (31.0 and 51.0 m length) and retaining walls in order to develop non-signalized intersection with approximate length of 1.0km.

Estimated implementation period of the contract is: 365 days.

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.

4. Only eligible bidders with, but not limited to, the following key qualifications should participate in this bidding in accordance with the following evaluation criteria:

- a) **Minimum Average Annual Construction Turnover of US\$ 25,500,000** - calculated as total certified payments received for contracts in progress or completed, within the last **3 (three)** years (in case of Joint Venture: All Partners Combined must meet requirement; Each Partner must meet 25 % of the requirement; One Partner must meet 50% of the requirement);
- b) **Financial Resources Requirement:** The Bidder must demonstrate that it has the financial resources to meet: (a) its current contract commitments, plus (b) the requirements for the Subject Contract of – **US\$ 3,000,000.00** (in case of Joint Venture: All Partners Combined must meet requirement; Each Partner must meet 25 % of the requirement; One Partner must meet 50% of the requirement);
- c) **Contracts of Similar Size and Nature:** Participation in at least **one** contract, that has been successfully or substantially completed within the last **5 (five)** years and that is similar to the

proposed works, where the value of the Bidder's participation exceeds **US\$ 10,000,000 million**.
