



## Invitation for Bids

Contract Title: Rehabilitation of Vani Archaeological Museum (Completion of new extension to the Museum Building) - (2 Phase)

**Reference No. IDA/RDPII/CW/NCB/17-2014**

1. The Georgia has received financing from the World Bank toward the cost of the Regional Development Project II, and intends to apply part of the proceeds toward payments under the contract for Rehabilitation of Vani Archaeological Museum (Completion of new extension to the Museum Building) - (2 Phase)

The project foresees the completion works related to the construction of Vani State Museum extension– a 4-sthrey building with flat roof. Installation of a temporary cover for ferroconcrete bearing structures and the roof is also planned. In order to protect the buildings, the openings of the extension will be boarded and covered with polyethylene.

### **Main construction woks:**

1. Installing monolith ferroconcrete structures – 428.8 m<sup>3</sup>;
2. Arranging block walls - 525.0 m<sup>3</sup>;
3. Installing temporary roof – 400.0 m<sup>2</sup>

The construction period is 5 (five) months from start date of the works.

The estimated cost of proposed works is **GEL 518,640.82** including all taxes, duties and other governmental levies as elaborated under clause ITB - 14.7. However it is the responsibility of the bidder to submit a bid price, which could be below or above the estimated cost, based on the current market prices and any other factors which may influence the pricing of the proposed works.

Qualifications requirements include and are not limited to:

- a. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years shall be GEL 1,900,000;
- b. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement GEL 350,000;

c. Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years that has been successfully and substantially completed and that is similar to the proposed Works, with a value of at least GEL 400,000;

2. The Municipal Development Fund of Georgia now invites sealed bids from eligible bidders for Rehabilitation of Vani Archaeological Museum (Completion of new extension to the Museum Building) - (2 Phase);

3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
