Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Oni Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/21).

Main works under the project are:

- 1. Installation of the steel pipeline from headworks to town Oni, with internal cement lining and external anticorrosive insulation of d=273x6-2,394 m, d=102x4.5-12m;
- 2. Installation of water supply network with PE d=25-110mm pipes 196m;
- 3. Replacement of amortized regulating equipment: d=250 2 pieces; d=200 8 pieces; d=150 6 pieces; d=100 18 pieces; d=50 1 piece;
- 4. Soil excavation = 2,909.5 m³;
- 5. Filling of the trench with ballast–7,983.72 m³;
- 6. Arrangement of the road metal above trench (thickness 0.2 m) 1.814m^2 ;
- 7. Arrangement of the gravel layer in the trench -860 m^3 .

Works under this contract are expected to be implemented from August 2014 through January 2015.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: GEL 2,000,000;
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: GEL 330,000.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.
