



## Invitation for Bids

Contract Title: **Safety Measure of Tusheti Road**

1. The Georgia has received financing from the World Bank toward the cost of the Regional Development Project, and intends to apply part of the proceeds toward payments under the contract for **Safety Measure of Tusheti Road**

Above mentioned road is situated in East Georgia, in town Akhmeta municipality, Kakheti region, 140 km distance from Tbilisi. Length of design road is 72 km. Problematic sections are already selected on entire line. Length of sections to be rehabilitated varies from 40-125m. Including: 7 lower supporting wall and one console balcony.

### **Main construction works:**

1. Fractional road metal - 1,033 m<sup>3</sup>
2. Sand gravel mixture - 220 m<sup>3</sup>
3. Concrete - 500 m<sup>3</sup>
4. Reinforcement - 270 m<sup>3</sup>
5. Fittings - 40,8 ton
6. I beam N24 - 4,0 ton
7. Gabion boxes - 44 m<sup>3</sup>.
8. Laid parapets – 108 m<sup>3</sup>

The construction period is 6 (six) months from start date of the works.

Qualifications requirements include and are not limited to:

- a. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years shall be GEL 1,800,000
- b. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other

than any contractual advance payments to meet the following cash-flow requirement GEL 400,000;

c. Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years that has been successfully and substantially completed and that is similar to the proposed Works, with a value of at least GEL 1,000,000 or less than or equal to 3 (three) contracts, each of minimum value GEL 350,000 but with total value of all contracts equal or more than GEL 1,000,000

2. The Municipal Development Fund of Georgia now invites sealed bids from eligible bidders for **Safety Measure of Tusheti Road**

3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
