The consultant will be responsible to engage all pertinent entities in the Georgian water and wastewater sector; primary support shall be to the UWSCG, but also the Ministry of Infrastructure and Regional Development and/or Ministry of Environment and Natural Resources Protection of Georgia (MENRP), especially regarding the institutional framework elements.

The assignment is expected to be completed by December 31, 2015.
