## Rehabilitation of Chiatura Water Supply System ICB No: EIB/WIMPII/W/NCB/07

1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of **Chiatura Water Supply System** for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/07).

2. *LEPL - Municipal Development Fund of Georgia* now invites sealed bids from eligible and qualified bidders for works:

Rehabilitation of Chiatura Water Supply System

Main works under the project are:

- 1. Soil Excavation -22,111m<sup>3</sup>
- 2. Sand bedding- 5,795 m<sup>3</sup>
- 3. Arrangement of road metal foundation-2,917 m<sup>3</sup>
- 4. Arrangement of gravel foundation– 516 m<sup>3</sup>
- 5. Backfilling of ballast in trench– 5,689 m<sup>3</sup>
- 6. Steel pipes D-57-219mm 16,656 m
- 7. Asphalt pavement- 20,767 m<sup>2</sup>
- 8. Concrete and r/concrete works- 250 m<sup>3</sup>
- 9. Metalwork-45 ton
- 10. Sandwich panels- 1,280 m<sup>2</sup>
- 11. Installation of sand filters with electrical and mechanical equipment-10 sets
- 12. Installation of water pumps with electrical equipment– 11 sets. (Q=100 m<sup>3</sup>/h;

H=110 m – 2 sets; Q=15 m<sup>3</sup>/h; H=145 m – 2 sets; Q=75 m<sup>3</sup>//h; H=85 m – 2 sets; Q=25

The construction period is 18 (Eighteen) months from start date of the works.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

5. Qualifications requirements include and are not limited to:

(a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 8,700,000**;

(b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 1,900,000.** 

(c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1<sup>st</sup> January 2009 and application submission deadline: (i) 1 (one) contract, of minimum value of GEL 6,900,000; or (ii) Less than or equal to 3 (three) contracts, each of minimum value GEL 2,300,000 but with total value of all contracts equal or more than GEL 6,900,000.

A margin of preference for certain goods manufactured domestically "*shall not*" be applied. Additional details are provided in the Bidding Documents.

A complete set of Bidding Documents in *English language* may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee *GEL 300* or equivalent in a convertible currency plus currier expenses if a bidder would like the Bidding documents to be sent by Courier.
