



## Invitation for Bids

Contract Title: **Site Cleanup and Reinstatement at Vardisubani, Entrance to Telavi**

1. The Georgia has received financing from the World Bank toward the cost of the Regional Development Project, and intends to apply part of the proceeds toward payments under the contract for **Site Cleanup and Reinstatement at Vardisubani, Entrance to Telavi**

Project envisages strengthening the bank of the Matsantsara River along the construction waste disposal area and harmonizing construction waste disposal area with natural environment at km65 - km67 section of Vaziani-Gombori-Telavi motor road. Works under the project include River bank protection by gabion boxes and rockfill; asbestos-containing waste collection, packaging, transportation and final disposal on the municipal solid waste landfill; vertical planning of river bank within the new boundaries of the project area, leveling, landscaping (sowing of grass).

### **Main construction works:**

1. Arrangement of walls with boxes of different sizes and filling with stones - 4,098 m<sup>3</sup>;
2. Rockfill – 3,022 m<sup>3</sup>;
3. Arrangement of storm water concrete chutes - 728 m;
4. Leveling and landscaping of the territory – 27,824 m<sup>2</sup>.
5. Collection, packaging, transportation and final disposal of asbestos-containing waste – 6 m<sup>3</sup>.

The construction period is 12 (twelve) months from start date of the works.

Qualifications requirements include and are not limited to:

a. Minimum average annual turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years shall be GEL 2,500,000

b. The Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash-flow requirement GEL 400,000;

c. Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years that has been successfully and substantially completed and that is similar to the proposed Works, with a value of at least GEL 1,400,000 or less than or equal to 3 (three) contracts, each of minimum value GEL 470,000 but with total value of all contracts equal or more than GEL 1,400,000

2. The Municipal Development Fund of Georgia now invites sealed bids from eligible bidders for **Site Cleanup and Reinstatement at Vardisubani, Entrance to Telavi;**

3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
