Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Gurjaani Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/22).

Main works under the project are:

- 1. Excavation of the III category soil 28,000m³;
- 2. Soil backfilling 19,060 m³;
- 3. Filling the trench with ballast $-5,790 \text{ m}^3$;
- 4. Arrangement of road metal layer (thickness 0.2m) $2,324m^3$;
- 5. Sand bedding 737m³;
- 6. Steel pipeline with external factory Insulation (d=325X6) 14,732m;
- 7. Steel pipe for casing (d=530X6) 161,2m;
- 8. Steel pipes (d=25÷219) 637m;
- 9. Polyethylene pipe PE-100 SDR17 PN10 (d=25÷160) 3,456 m;
- 10. Reinforced mass concrete B-25 57.1m³; B20 56.2m³;
- 11. Steel Constructions 2.54 t.

Works under this contract are expected to be implemented from August 2014 through November 2015.

The estimated cost of proposed works is **GEL 4,053,986.00** including all taxes, duties and other governmental levies as elaborated under clause ITB - 14.7.

- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

- 5. Qualifications requirements include and are not limited to:
 - (a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 4,500,000**;
 - (b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 1,000,000**.
 - (c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January 2009 and application submission deadline: (i) 1 (one)

contract, of minimum value of **GEL 3,200,000.00**; or (ii) Less than or equal to **3 (three)** contracts, each of minimum value **GEL 1,100,000.00** but with total value of all contracts equal or more than **GEL 3,200,000.00**.

A margin of preference for certain goods manufactured domestically "shall not" be applied. Additional details are provided in the Bidding Documents.
