### **Rehabilitation of Likani Water Supply System**

1. Georgia has received a loan from the European Investment Bank (hereinafter referred to as "the Bank") toward the cost of Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds of this credit to payments under the Contract for Rehabilitation of Likani Water Supply System for *The United Water Supply Company of Georgia* (Contract # EIB/WIMPII/W/NCB/28).

2. *LEPL - Municipal Development Fund of Georgia* (Employer) now invites sealed bids from eligible and qualified bidders for works:

#### **Rehabilitation of Likani Water Supply System**

Main works under the project are:

1. Installation steel pipeline D=219 mm – 408 m;
2. Installation of networks with steel pipes d=20-219mm - 210m;
3. River crossing with steel casing pipe (d=1,200 mm – 70 m) and construction of middle support for crossing with drilled pile (d=1200 mm, H=12 m);
4. Installation of Polyethylene pipelines (PE100 SDR17, PN10), (SDR11, PN16) D=225mm – 2,345m;
5. Construction of round reinforced concrete 500m<sup>3</sup> capacity reservoir;
6. Installation of drainage pipeline at reservoir site with PE pipes (SDR 17 PN10; SDR 11 PN 16) d=200mm - 95m;
7. Soil excavation (III – V category) – 4,155 m<sup>3</sup>;
8. Trench backfill – 2,320 m<sup>3</sup>;
9. Arrangement of asphalt pavement – 390 m<sup>2</sup>.

Works under this contract are expected to be implemented from **August 2014** through **May 2015**.

The estimated cost of proposed works is **GEL 1,005,157.00** including all taxes, duties and other governmental levies as elaborated under clause ITB - 14.7.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the EIB's *Guidelines: Guide to Procurement, June 2011* and is open to all bidders from Eligible Source.

4. 5. Qualifications requirements include and are not limited to:

(a) The minimum required average annual turnover of construction works for the successful Bidder in the last three years shall be: **GEL 1,800,000**;

(b) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments shall be: **GEL 300,000**.

(c) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between **1<sup>st</sup> January 2009** and application submission deadline: (i) **1 (one)**

contract, of minimum value of **GEL 800,000**; or (ii) Less than or equal to **3 (three)** contracts, each of minimum value **GEL 270,000** but with total value of all contracts equal or more than **GEL 800,000**.

A margin of preference for certain goods manufactured domestically “*shall not*” be applied. Additional details are provided in the Bidding Documents.

6. A complete set of Bidding Documents in **English language** may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee **GEL 300** or equivalent in a convertible currency plus courier expenses if a bidder would like the Bidding documents to be sent by Courier. Based on written request, against presented evidence of the remittance, the Bidding Documents may be sent by courier service if the transport is previously ordered by the Bidder in his country. The Employer bears no responsibility for the delivery in such a case.

Bids will be opened in the presence of the bidders' representatives who choose to attend in person address below at 15:00 (local time), June 06, 2014.

All bids must be accompanied by a “Bid Security” of **GEL 20,000 (Twenty Thousand)** equivalent. A Bid-Securing Declaration is not required.
